Developing Strategies for the Cyber Security,  
Safety, and Ethics Awareness Campaign**

The National Cyber Security Alliance (NCSA) and its supporting partners, including the Cyber Security Industry Alliance (CSIA) and the Department of Homeland Security (DHS), are hosting a roundtable series focused on developing a "National Cyber Security, Safety, and Ethics Awareness Campaign," to decrease and eventually eradicate cyber crimes against children and teenagers, and increase national awareness about proper Cyber Security, Safety and Ethical Uses of technology and the Internet in today's setting.

The second roundtable on March 14, 2006 will focus on reviewing a draft strategy for implementing the national awareness campaign, which was developed using ideas generated from the previous roundtable held in December. We seek your input on ways to implement this draft strategy and the awareness campaign, so that messages will resonate with educators, administrators, parents and children. More specifically, we will focus on the following discussion points during the roundtable:

  - o K-12 activities to implement during October will include:
    - Radio and Newspaper Child Safety and Security Public Service Announcements
    - Grassroots Cyber Security, Safety and Ethics Events
    - Cyber Security and Safety Contests for Children
    - School assemblies – Work with partners
- Insights into how to expand the National Cyber Security, Safety and Ethics Awareness Campaign in 2007
- Website
  - o Create a central location for cyber education material and criteria required for posting
- Share information on upcoming cyber security, safety and ethics events

This series will examine various strategies and tactics that will be used to implement a national campaign that will teach our children and young adults how to become good "cyber citizens,"

especially as we prepare them for the 21<sup>st</sup> Century Workforce. Integrating the appropriate use of technology and the Internet in K-12 classrooms and at home, plus increased awareness of cyber security, safety, and ethics will position students to succeed in the workplace.
