# WHAT IS A SECURITY CLEARANCE?

Certain information and locations are protected by law. In order to access confidential information or locations an individual must be investigated to assure that he or she will keep this information and what goes on in these locations secret.

3. Judgment


## REPUTATION MANAGEMENT TIPS

# The Security Clearance Investigation

The background investigation helps determine your honesty, trustworthiness, reliability, discretion, character, judgment, and unquestioned loyalty to the United States. There are 13 Adjudicative guidelines used in the security clearance investigation:

- Allegiance to the United States
  - Foreign Influence
  - Foreign Preference
  - Sexual Behavior
  - Personal Conduct
  - Financial Considerations
  - Alcohol Consumption
  - Drug Involvement
  - Psychological Conditions
  - Handling Protected Information
  - Criminal Conduct
  - Outside Activities
  - Use of Information Technology Systems

## Nobody's Perfect: What if I make a mistake?

There is a process which looks at the mistake you made to determine whether or not you will earn your clearance. This process reviews your conduct for the following 9 characteristics:

1. The nature, extent, and seriousness of the conduct;
2. The circumstances surrounding the conduct, to include knowledgeable participation;
3. The frequency of the conduct; behavioral changes;
4. The individual's age and maturity at the time of the conduct;
5. The voluntariness of participation;
6. The presence or absence of rehabilitation and other pertinent
7. The motivation for the conduct;
8. The potential for pressure, coercion, exploitation, or duress; and
9. The likelihood of continuation or recurrence.
